## 2005-146 – Guilty verdict in Jefferson Parish Oyster Case

Two Plaquemines Parish men were found guilty of illegally taking oysters from unleased state water bottoms in Jefferson Parish on May 23. Terrence Shelley, 53, and Roger Ancar, 62, both of Belle Chasse were each ordered to pay a fine of \$400 plus court costs by Judge Roy M. Cascio of 2nd Parish Court. A third defendant, Timothy S. Kirk, 39, of Harvey, missed the trial date and Cascio issued a bench warrant of attachment for his arrest. The investigation began in December of 2002 when Louisiana Department of Wildlife and Fisheries (LDWF) Enforcement Division agents apprehended

Shelley and two deckhands taking oysters from unleased state water bottoms near Bayou Dos Gris. Shelley claimed he held a legal lease on the water bottoms. Technicians from the LDWF Oyster Lease Survey Section plotted GPS coordinates that determined these water bottoms were owned by the State of Louisiana. Raymond Impastato from the LDWF Oyster Lease Survey Section and John Evans from the Office of State Lands both testified as expert witnesses that the area of the violation was owned by Louisiana and not under lease. Sgts. James Gregoire and Rachel Zechenelly, and Senior Agent Eddie Skena participated in the investigation. Assistant District Attorney Jeremy LaFleur with assistance from Assistant District Attorneys Loren MaGee and Evette Ungar from the office of Paul Connick, District Attorney for the 24th Judicial District in Jefferson Parish, tried the case.

## **Physical Injury Matter**

May 14, 2014, 24th JDC returned a verdict in favor of Jeffrey Scorsone against GEICO for Physical Pain & Suffering and Mental Anguish \$250,000, Loss of enjoyment of Life (Past & Future) \$50,000, Medical Expenses past and future, \$300,000.
